Substantive content

CLASSES: The evolution of the American legal system. The Constitutional Convention and governmental structure of the United States provided for in the Constitution of 1787. Interpretations of "Living Constitution" in the American legal and political discourse. Sources of law. Kinds of law. Legal procedure. The federal and state court system. Judicial selection. The presentation of the legal system of the chosen American states (historical aspects, state administration, state constitution, state court system).

LECTURES: Introduction to the course. Main content and bibliography, methodology of the course, evaluation process. Historical roots of the American federal administration and English influences on the American legal system. The nature of the American legal system in connection with the American administrative division. The historical background of the United States patent law. Historical Background and the Main Ideas of the American Uniform Commercial Code of 1952. The tradition of ADR (Alternative Dispute Resolution) as an alterative form of justice in the American legal culture.

Learning purpose: The main goal of the course is to know and understand the background of the American legal system (English influences, sources of law, the federal and state court system and judicial selection).

On completion of the study programme the graduate will gain:

Knowledge: Students acquired knowledge on the American legal system. Students broadened their knowledge concerning the American legal culture.
